Dear Senator Alexander,

On behalf of the children of our state, we want to thank you for your service to South Carolina. When you return to Columbia in January, we recognize that you and your colleagues will face some of the toughest **budgetary** decisions that our state has ever encountered. Our organization, Focus on Kids, is asking that you make children's healthcare the number one priority in your deliberations.

As you can see from the list on the following page, Focus on Kids has brought together diverse children's organizations, faith-based groups, and other advocates for the sole purpose of making children's issues a priority in South Carolina. Our mission is to protect and improve the lives of our state's most valuable asset, our youngest citizens, by promoting policies that will optimize their success. We are contacting you today on their behalf and asking you to join us by ensuring that their voices will not be lost during the budget debate. We are asking you to lead the effort to ensure that the needs of children are a top priority when tough decisions must be made.

One of the most important investments you can make while working over the next session is ensuring that all of our children have the opportunity to grow up healthy so they can become productive citizens. For this reason the undersigned groups, representing thousands of your friends and neighbors, are making a simple request: protect children's healthcare.

It is critical that reductions are not made in the Children's Health Insurance Program (CHIP) and Medicaid program. Over the past decade these health care programs have proven to be a successful investment in the healthcare of our children. Not only does it make moral sense to keep them funded, it also makes fiscal sense. The federal match for both Medicaid and CHIP allows our doctors, hospitals and health clinics to provide needed services and spends money in our local communities to support jobs and the economy. Maintaining full funding for CHIP and Medicaid just makes sense for now and our future. Currently, between 60,000 and 137,000 of our state's children do not have health insurance. Cuts in either of these programs would make these numbers grow exponentially.

Children are our most vulnerable citizens, and their well-being depends on the actions that you will take during next year's session. Focus on Kids is committed to protecting the health and welfare of our children, especially in times of limited resources. As our elected leader, we strongly urge you to help maintain the viability
